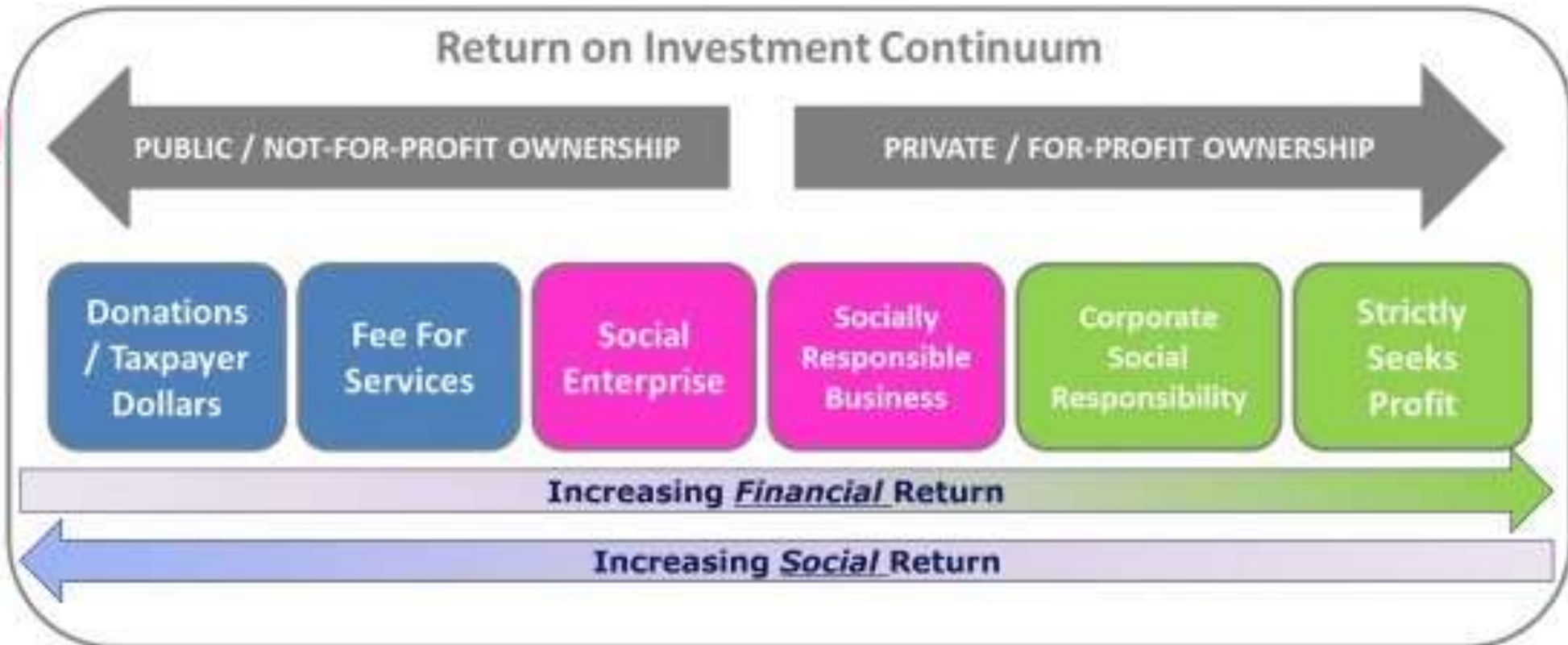






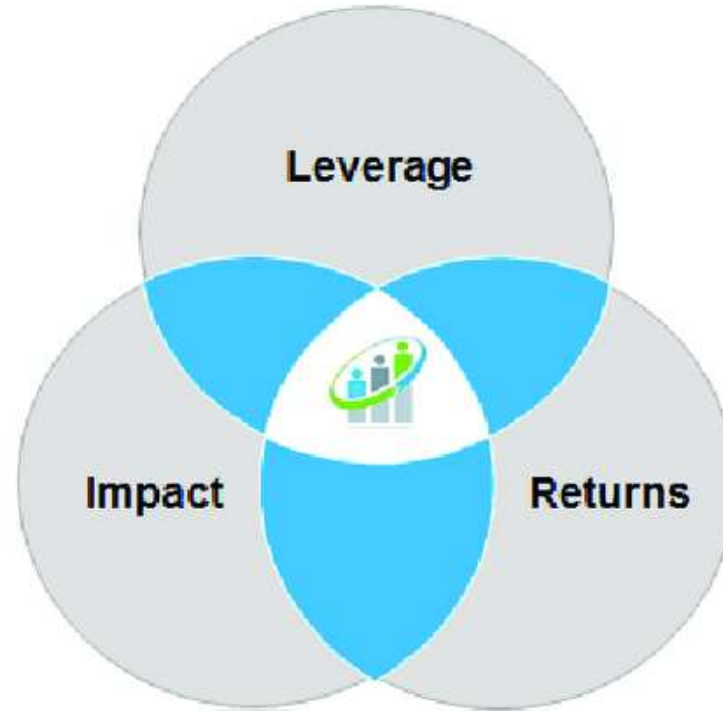






### **Leverage:**
